

STALLION SERVICE CONTRACT FOR FROZEN SEMEN FROM RAWHIDE WHIZ

This contract made this _____ day of _____, _____ by and between Toni Perdew/Cedar Ridge Quarter Horses (stallion owner) and _____ (mare owner, also referred to as Buyer).

COSTS

Single mare, \$650. Multiple-mare discounts: 1st mare, \$650. 2nd-3rd mares, \$600 each. 4th and subsequent mares, \$550 each. Each mare requires an individual contract. Multiple-mare discounts are applicable for multiple mares owned by the same owner, and for the same breeding season.

Toni Perdew agrees to approve shipment of 12 (twelve) straws of frozen semen for one mare from the stallion Rawhide Whiz to Buyer for a breeding fee of \$_____ (**\$650** unless this is a 2nd, 3rd, etc. mare to utilize a multiple-mare discount; see above), to be used on ONE mare to conceive ONE foal. In addition to the breeding fee, a shipping, lab charge, and deposit fee (for the shipping container) will be due to the semen center prior to shipping. Additional straws may be purchased at \$15 per straw for this same mare in this same season. Buyer and Buyer's veterinarian will be responsible for returning any shipping materials immediately to the semen center listed with the shipment.

SPECIFICS

- The frozen semen fees are payable upon execution of this contract. Buyer specifically agrees and understands that no semen will be shipped until all fees have been paid to Toni Perdew in confirmed funds (wire transfer, certified check or money order 2+ weeks in advance, etc.).
- This semen is to be used to inseminate one mare only, whose name will be specified on this contract.
- Toni Perdew assumes responsibility to approve the shipment of the frozen semen from Vogler Semen Centre at the time of sale.
- The semen must be administered by a licensed Veterinarian or reproduction specialist familiar with the concept and practical use of frozen equine semen. Your mare must be present at your Veterinarian's facility or a qualified insemination station during her cycle and she must be bred there. Attempts to use frozen semen outside the controlled situation of a qualified facility can greatly reduce, or even prevent, chances of conception.
- Buyer agrees to hold harmless Toni Perdew and/or any semen distribution agents for Toni Perdew for any injury or illness to mares associated in any way with the insemination of frozen semen provided by Toni Perdew.
- Mare owner must notify stallion owner of any state permit requirements (for example, EVA test results) by the mare owner resident state in a suitable period prior to the anticipated shipment date, allowing the stallion owner sufficient time to obtain those permits.
- A modified Life Foal Guarantee is offered with the use of frozen semen in that the buyer may buy and ship up to 16 additional straws of semen for this mare to inseminate her if not successful with the first order(s). Additional straws may be granted under agreed-upon circumstances. No refund will be offered if the mare fails to settle. *Buyer specifically understands that Toni Perdew makes no guarantees or warranty as to the success probabilities for conception via this semen, as the mare's reproductive health and the veterinarian's skill are beyond Toni Perdew's control. A veterinarian skilled with frozen semen will obtain successful results a high percentage of the time, but an unskilled one may not have success.* Cedar Ridge Quarter Horses/Toni Perdew will be held harmless if mare fails to settle for any reason. An option to order fresh cooled semen can be discussed with payment of the remaining regular stud fee to a different stallion, plus an agreed-upon fee for straws used. We can't stress enough the importance of having a highly-qualified specialist that is familiar with the use of frozen equine semen.
- UNUSED STRAWS: If the mare in this contract settles without using all of the straws of semen paid for by the mare owner, the mare owner may hold those straws to be used for a future breeding once that future breeding's stud fee is paid to Toni Perdew. If no future breeding is desired and purchased, the unused straws may be discarded. They cannot be returned for a refund.

- Mare owner is responsible for ascertaining their mare's registry requirements for the use of frozen semen and subsequent registration of foals conceived through the use of frozen semen. Mare owner must ensure that their veterinarian files appropriate paperwork with their registration organization, if needed. This stallion is approved for AQHA. If you need an additional registry listing, contact us. We may list him if you pay the listing fee.
- Send a copy of all registration papers applicable to the mare/s to be bred with the frozen semen. We also need the name, address and phone number of the equine Veterinarian that will be responsible for inseminating the mare, and within a week post-insemination, the date the mare was inseminated.
- Please note that the semen will be shipped ONLY from Vogler's Semen Centre', and not from Toni Perdew. Semen will only be shipped directly to the Veterinarian/specialist - no exceptions.
- This contract is governed by the laws of the State of Iowa, and Taylor County. All accounts are due and payable in Taylor County, Iowa. All costs are quoted in US dollars.

For your convenience, you might choose to use the following timeline after contacting us:

1. Prior to paying a stud fee, consult with your veterinarian to see if she/he has any questions regarding breeding your mare with frozen semen. Be sure your vet is comfortable and experienced with the use of frozen (not cooled) equine semen. Once this is verified, contact us to make sure we have frozen semen on hand. Then, send the fee (or wire transfer) to Toni Perdew, c/o Cedar Ridge Quarter Horses, 3005 Lexington Court., Bedford, IA 50833 with a copy of your mare's papers.
2. We highly recommend a recent cervical culture and/or uterine biopsy (suggested for barren mares or maiden mares over the age of 3 years, or any mare that has a history of breeding problems or was unable to conceive the previous breeding season.)
3. For successful breeding with frozen semen, it is highly recommended that breeding be done as close to ovulation as possible (within 4 hours).
4. Ultrasound mare 16+ days post insemination to determine if pregnancy has occurred, and notify Toni of the results..
5. Remember, unlike cooled transported semen, frozen semen can be shipped well in advance of insemination. It costs less for ground shipments, rather than overnight or 2nd Day Air. If your vet has storage facilities for frozen semen, you may be able to order it any time after payment for the breeding fee is processed with the return of this contract. Ask your vet for details.
